

#### OMNICOMMANDER to Expand Operations in Williamson County

BRENTWOOD (May) OMNICOMMANDER officials announced the company will invest \$1.3 million to expand its Brentwood, Tennessee, flagship office by hiring several key positions over the next two years.

# Independent Stave Company to Establish Manufacturing Operations in Overton County

**RICKMAN (June)** Independent Stave Company will invest \$30 million to establish new manufacturing operations through its subsidiary American Stave Company in Rickman, Tennessee.

Independent Stave Company will create 85 new jobs in Tier 4, At-Risk Overton County. Upon completion of the project, the company will employ nearly 100 Tennesseans.



Independent Stave Company will construct a new stave mill at its Rickman property, which will be the company's eleventh stave mill in the U.S. The additional production facility will help meet the continued growth needs of its customers.

American Stave Company, LLC, is a subsidiary of Independent Stave Company, a family-owned cooperage that was established in 1912 and manufactures staves, barrels and oak alternatives for customers in more than 40 countries around the world.

TNECD (June) Economic and Community
Development Commissioner Stuart McWhorter
announced 10 new Site Development Grant
recipients. The grants, totaling approximately \$5.9
million, are designed to help communities invest in
infrastructure and engineering improvements to
land economic development projects and achieve
Select Tennessee site certification.

"We're committed to providing rural communities with the resources needed to support continued investment and create quality jobs for Tennesseans," said Lee. "I thank the General Assembly for partnering with us to fund these 10 additional industrial sites and look forward to the economic growth and opportunity that will result from these projects."

The Site Development Grant program, part of the Rural Economic Opportunity Act, works in tandem with TNECD's Select Tennessee program. Since

2016, TNECD has awarded 153 Site Development Grants across the state, totaling more than \$60 million in assistance to local communities and generating approximately 6,400 new jobs for Tennesseans.

"The latest round of the Site Development program will bring 10 Tennessee communities one step closer to achieving Select Tennessee Site Certification," said McWhorter. "Shovel-ready sites are in high demand, and through this program, we are working with local leadership across the state to bring this needed infrastructure to every community."

Each application was supported by the community's senator and representatives in the Tennessee General Assembly.



#### Driving Electric in Tennessee Just Got Easier

Hohenwald will soon connect to Fast Charge TN and regional Fast Charge Network

CENTERVILLE (June) Meriwether Lewis Electric Cooperative announced that it has installed two chargers at its 28 Park Avenue South, Hohenwald, Tennessee office as part of Fast Charge TN, a partnership between the Tennessee Valley Authority (TVA) and the Tennessee Department of Environment and Conservation (TDEC), and Seven States Power Corporation. This Fast Charge TN installation is part of the regional Fast Charge Network that will cover major travel corridors across TVA's seven-state service area and will complement the broader efforts of the National Electric Highway Coalition, which seeks to enable long-distance EV travel by placing fast chargers along interstates and major highways throughout the United States.

TVA and TDEC have brought together local power companies, state and local government partners, and others to pave the way for over 200,000 EVs on Tennessee Valley roads by 2028. The benefits that these EVs bring to the Tennessee Valley region are significant:

- Attracting good jobs -- \$13.8 billion in EV and battery manufacturing have helped create over 10,000 EV-related jobs.
- Reducing carbon emissions from gasoline vehicles by almost 1 million metric tons per year or the equivalent of the carbon sequestered by 1 million acres of US forests in one year.
- Reinvesting \$120 million in the local economy every year from electric refueling.
- Saving drivers up to \$1,000 in fuel and maintenance costs every year.

"This charging location does more than charge cars — it connects Hohenwald to the Fast Charge Network and plays an important role in putting our region on the leading edge of the new electric economy," said Keith Carnahan, MLEC President and CEO.

# Blickman Industries, LLC to Establish Manufacturing Operations in Lawrence County

**LAWRENCEBURG (July)** Blickman Industries, LLC officials announced that the company will invest \$2.7 million to establish manufacturing operations in Lawrenceburg, Tennessee, creating 48 new jobs in Lawrence County.

Founded in 1889, Blickman Industries provides the healthcare industry with groundbreaking stainless steel and chrome solutions. The company offers the highest quality medical equipment and services to acute care hospitals, primary care offices and surgery centers across the nation.

#### Magna to be the First Supplier at Ford's BlueOval City Supplier Park

**STANTON (July)** Magna will invest more than \$790 million to build the first two supplier facilities at Ford's BlueOval City supplier park in Stanton, Tennessee.

In addition to the two West Tennessee locations, Magna will also build a stamping and assembly facility in Lawrenceburg, Tennessee.

Combined, Magna will create approximately 1,300 new jobs in Tennessee.

Ford's on-site supplier park will allow for vertical integration that helps ensure efficient production at BlueOval City, which will be capable of producing 500,000 electric trucks a year at full production. Magna will supply Ford's BlueOval City with battery enclosures, truck frames and seats for the automaker's second-generation electric truck.

Magna's two facilities at BlueOval City supplier park include a new 800,000-square-foot frame and battery enclosures facility and a 140,000-square-foot seating facility.

The battery enclosures facility will join one of Magna's sister plants in Ontario, Canada, which is currently producing battery enclosures for the Ford F-150 Lightning. The seating facility will



produce polyurethane foam, and assemble and sequence "just-in-time" (JIT) complete seats.

Magna will employ approximately 750 employees at its battery enclosures facility and 300 employees at its new seating plant.

In addition, Magna will construct a new 400,000-square-foot stamping and assembly plant at the Team Lawrence Commerce Park – West, a Select Tennessee Certified Site in Lawrenceburg, Tennessee, that will produce truck frames. Magna will employ roughly 250 employees at this location.

Production at all three plants is scheduled to begin in 2025.

Tennessee has made significant strides in electric vehicle (EV) manufacturing with investments from companies like Magna. During Gov. Lee's administration, more than \$14.8 billion has been invested in Tennessee and nearly 11,000 new jobs have been committed through EV-related projects.

#### McNeilus to Expand Manufacturing Operations in Murfreesboro



MURFREESBORO (July) McNeilus Truck and Manufacturing, Inc., an Oshkosh Corporation [NYSE: OSK] company, will invest \$25.2 million to expand its manufacturing presence in Middle Tennessee.

Nearly one year after announcing plans to locate in Rutherford County with its McNeilus business, an additional 100 new jobs are being created at the Parkway Place facility in Murfreesboro for the fabrication and weldment of custom vehicle components.

The expansion will increase the company's production capacity and allow for building improvements, updated infrastructure, machinery and equipment to better support the company's global customer base.

McNeilus Truck and Manufacturing, Inc. is a market leader and manufacturer of purpose-built commercial vehicles and equipment. Over the next five years, the Oshkosh Corporation business will employ more than 300 people in Rutherford County.

# Lochinvar, LLC to Expand Manufacturing Operations in Lebanon

**LEBANON (August)** Lochinvar, LLC officials announced today the company will invest \$35 million to expand manufacturing operations at its headquarters in Lebanon, Tennessee.

Through the project, Lochinvar will create 141 new jobs in Wilson County.

Located at 300 Maddox-Simpson Parkway, the expansion will allow Lochinvar to house its state-of-the-art engineering, product management and support, platform electronics and development laboratories under one roof.

Lochinvar, LLC was founded in 1939, and is a subsidiary to A.O. Smith Corporation (NYSE: AOS). The company specializes in high-efficiency water heating and manufactures residential and commercial boilers. commercial water heaters.



heat pumps, pool and spa heaters and storage tanks. With the additional 141 new positions in Lebanon, A.O. Smith will employ nearly 4,000 people in Tennessee across its operations in Cheatham, Washington, Wilson, Davidson, Putnam and Williamson counties.



In July, we successfully concluded the 2023 Middle Tennessee Wage and Benefit Survey. This was the fourth biennial update to the inaugural 2017 survey. All too often, it is incredibly difficult, if not impossible, to obtain locally sourced information about a region's prevailing compensation structure. Despite the difficulty, this information is needed by industries seeking to hire or retain workers. In the absence of locally sourced information, companies and communities are dependent on national aggregations and antidotal information. Such information puts industries at a disadvantage when determining the wages and benefits needed to staff their operations. Because of a broad partnership and the expertise of MTSU's Business and Economic Research Center, the 40 counties in the middle of Tennessee now have a reliable dataset that can assist industries make more informed staffing decisions. This year over 300 industries participated and received the reports resulting from the survey between February and April. Over 56,000 Tennesseans are employed at these companies.

The 2023 update was accomplished under the direction of Dr. Murat Arik at MTSU's Business and Economic Research Center (BERC). To make these results as broadly useful and locally meaningful as possible, BERC compiled multiple reports targeting various geographic subregions. Occupation Profiles and Summary Tables are available focused on nine (9) smaller geographic areas as well as detailed reports for the larger Upper Cumberland, Southern and Northern Middle, and Nashville Partnership 2030 regions. Just as with the previous three surveys, we continue to see the value of this project during either visits with prospective companies asking for this information or through conversations with local staff who can better assist existing industries.

It is our hope to continue and improve this project in future years. To assist with this improvement, we held a workshop with local and regional partners in August to discuss their experiences with the 2023 survey. Also, the Nashville Chamber of Commerce's research staff conducted a follow-up survey to help identify what worked well in 2023 and what needs improvement or change.
